ALL STUDENTS PLANNING ON GRADUATING IN MAY TWO THOUSAND AND FIFTEEN MUST SUBMIT THEIR GRADUATION CLEARANCE APPLICATIONS TO THE REGISTRAR'S OFFICE NO LATER THAN AUGUST EIGHTEENTH TWO THOUSAND AND FIFTEEN BY FIVE O CLOCK P.M. STUDENTS MAY PICK UP THEIR GRADUATION CLEARANCE APPLICATION FROM THE REGISTRAR'S OFFICE LOCATED NEAR SWEETHEART CIRCLE IN THE ROSENWALD BUILDING. THE REGISTRAR'S OFFICE IS OPEN MONDAY THROUGH FRIDAY FROM EIGHT A.M. TO FIVE P.M. BEFORE SUBMITTING GRADUATION CLEARANCE APPLICATIONS, STUDENTS MUST MEET WITH THEIR SPECIFIC ACADEMIC ADVISORS TO FILL OUT AND SIGN THE APPLICATION. AFTER MEETING WITH THEIR ADVISOR, STUDENTS MAY SUBMIT THEIR GRADUATION CLEARANCE APPLICATION BACK TO THE REGISTRAR'S OFFICE. STUDENTS WHO SUBMIT THE GRADUATION CLEARANCE APPLICATION AFTER THE DEADLINE OF AUGUST EIGHTEENTH TWO THOUSAND AND FIFTEEN WILL BE REQUIRED TO PAY A LATE FEE OF SEVENTY-FIVE DOLLARS, AND ARE SUBJECT TO A DELAY IN THEIR GRADUATION PROCESS.
